3. Discussion of Insurance Renewal Proposal – Curtis & Harris Insurance Services

Hugh Curtis from Curtis & Harris Insurance Services gave a presentation of the proposed 2017/2018 insurance renewal. DIRECTOR DURAN asked for clarification of the insurance ratings. The Board thanked Mr. Curtis for his continued hard work for the District. Information only item.

4. Award of Contract – 8 Foot High, Anti-Climb, Anti-Cut Fence Project to Moore Fence Company

Staff is working on the design of the next phase of the new fence extension along the north and east sides of the District's property. This is the most likely access point for thieves and vandals to enter the property. As part of this project, an 8 foot high, anti-climb, anti-cut fence extension will be constructed along the eastern perimeter to deter entry onto District Property. This is the initial phase of an upgraded anti-climb, anti-cut fence, improved lighting, and extension of the closed circuit television systems. In order to expedite this project, Staff solicited three (3) quotes from vendors that are authorized to purchase and install the Ameristar Fence, a specialized anti-climb and anti-cut wired fence. Moore Fence Company was the apparent low bidder for a not to exceed total of \$312,000.
