The District currently uses the Encore 700 pumps for de-chlorination and they have proven to be a dependable metering pump for over 15 years. In order to replicate the redundancy at the district's de-chlorination facility, staff recommends the Encore 700 metering pumps for chlorination.

DIRECTOR COLEMAN made a motion to authorize the General Manager to purchase four (4) Encore pumps, four (4) pump controllers, two (2) dual pump skids, programming of PLC-600 and SCADA, and necessary electrical and plumbing supplies to complete installation for a total cost of \$72,650.60.
