4. Consideration of Resolution 2013-1048 - A RESOLUTION OF THE BOARD OF DIRECTORS OF VALLEY SANITARY DISTRICT DETERMINING CERTAIN ACCOUNTS TO BE DELINQUENT AND DIRECTING THE PLACEMENT OF THESE ACCOUNTS ON THE COUNTY PROPERTY TAX ROLL FOR COLLECTION.

PRESIDENT YORK asked the general manager to give a brief summary of the actions leading up to the hearing. MR. GLOWITZ noted that each year pursuant to Health & Safety Code Section 6062a, notice is given of the Public Hearing regarding the placement of delinquent accounts on the County Property Tax Roll for collection. This year's notice was mailed directly to the property owners, as well as placed on the District's website. PRESIDENT YORK issued the procedures to be followed during the Hearing.

MR. GLOWITZ directed the Board's attention to the list of delinquent accounts and explained that each of the accounts listed were at least 60 days past due as required under Section 6520.11 of the Health & Safety Code and that each of the assesses has been notified by mail that the delinquent charges could become a lien on the property. There had been no written communication received regarding any of the delinquent accounts.

PRESIDENT YORK declared the Public Hearing open for public comment at 1:13 p.m.

There being no correspondence, public comments or additional comments from the Board, PRESIDENT YORK declared the Public Hearing CLOSED at 1:15 p.m.

5. Award of Bid – Transport of Digester Seed Sludge

MR. GLOWITZ informed the Board that the digester will require startup seed sludge in order to bring the new digester into operation. Eastern Municipal Water District has agreed to supply the 80,000 gallons of digester seed sludge. It is recommended that award of contract for delivery of the seed sludge go to the lowest bidder, American Integrated Services, Inc. (AIS)

MOTION: DIRECTOR WISEMAN made a motion to award the contact to American Integrated Services, Inc. (AIS) and to authorize the General Manager to execute a contract for the purpose of delivering seed sludge from Eastern Municipal Water District to Valley Sanitary District in the amount of \$13,500. 6. Manager's Notes

MR. GLOWITZ passed out a report from the County of Riverside showing amount the District will be receiving from the Fixed Charge Special Assessment for 2013. He also passed out a copy of the flow chart showing the 22 mgd that came through the plant during the rainstorm on August 25. The quick thinking of the operator on call led the plant to handle the flow with minimal issues and no violations. Meeting with the County of Riverside EDA regarding the East County Detention Center for clarifications for the Will Serve letters. The completion of the Requa Ave. project will be essential in establishing service for the new jail.
