3. Refrigerator-Incubator Replacement

The current Refrigerator-Incubator in the lab is over 20 years old and needs to be replaced due to aged equipment resulting in low accuracy and precision. It is recommended to purchase a new Refrigerator-Incubator from Thomas Scientific for \$3,443.68.

4. Reimbursement Agreement for "Excess Portion" of Off-Site Improvements, dated October 27, 1999, between Valley Sanitary District and S & D Indian Palms, California, Ltd.

MR. GLOWTIZ reported that on October 26, 1999, the Board of Directors of Valley Sanitary District entered into a reimbursement agreement with S & D Indian Palms to reimburse said developer for the cost of oversizing several thousand feet of sewer main along Jackson Street and Ave. 48 in order to better serve the surrounding areas tributary to these sewer mains. As part of the agreement, VSD was to pay \$115 per Equivalent Dwelling Unit (EDU) for every EDU collected as part of the connection capacity fee until the \$494,174 was reimbursed or 20 years expires, whichever came first. The District performed a reconciliation of the records to determine the outstanding completed improvements and owes \$173,132.50 in reimbursement fees.

# ACTION TAKEN: MOTION:

DIRECTOR WISEMAN made a motion to authorize the General Manager to reimburse Anchor Bank, successor in interest to S & D Indian Palms California Ltd. in the amount of \$173,132.50 pursuant to the Reimbursement Agreement for "Excess Portion" of Off-Site Improvements, dated October 27, 1999, and to negotiate closing out the agreement by paying off the balance due. DIRECTOR DURAN seconded the motion. Motion carried by the following vote: 4 yes
