A regular Board Meeting of the Governing Board of Valley Sanitary District (VSD) was held at the District offices, 45-500 Van Buren Street, Indio, California, on Tuesday, June 24, 2014.

2. Consideration of the June 10, 2014 Regular Board Meeting Minutes

DIRECTOR DURAN made a motion to approve the minutes for the Regular Board Meeting held JUNE 10, 2014. DIRECTOR FRIESTAD seconded the motion. Motion carried by the following vote: 5 yes

NON-HEARING ITEMS

3. Award a Construction Project to Borden Excavation and Authorize the General Manager to Execute a Construction Contract

There are two manholes located on Gore Street north of Avenue 42 that are 1 to 2 inches higher than the surrounding pavement and need to be adjusted. The City of Indio is requesting the District lower both manholes to grade as well as lower a 16 foot by 16 foot section of pavement around one manhole.

ACTION TAKEN: MOTION:

DIRECTOR TEAGUE made a motion to award a construction contract to Borden Excavation, Inc., and authorize the General Manager to execute a construction contract for a not to exceed price of \$11,322 to adjust two manholes to grade on Gore Street including other related work. DIRECTOR FRIESTAD seconded the motion. Motion carried by the following vote: 5 yes

4. Requa Interceptor Design Project – Additional Design Services

Due to the Requa Interceptor's size and significance, a new model run with all current design parameters including sewer main slope is recommended to verify that the proposed sewer main will perform as needed today and into the future. It is recommended to execute an addendum to the HDR Engineering Requa Interceptor Design Contract.

ACTION TAKEN: MOTION:

DIRECTOR DURAN made a motion to authorize the General Manager to execute an addendum to the Requa Interceptor Final Design Contract with HDR Engineering, Inc. for a not to exceed fee for \$7,500. DIRECTOR WISEMAN seconded the motion. Motion carried by the following vote: 5 yes

5. Performance of an Arc Flash Analysis for Select Electrical Equipment for Valley Sanitary District in Conjunction with the Treatment Plant Upgrade and Expansion Project

The arc flash hazard analysis is a safety analysis and report that will provide the calculated arc flash incident energy for selected electrical equipment as well as provide the arc flash protective boundary and the required personal protective equipment that must be worn within the arc flash boundary. It is required by Cal-OSHA to have a comprehensive arc flash hazard analysis performed.

ACTION TAKEN: MOTION:

DIRECTOR WISEMAN made a motion to authorize the General Manager to enter into a professional services agreement with HDR Engineering, Inc. for a not to exceed fee of \$63,500. DIRECTOR DURAN seconded the motion. Motion carried by the following vote: 5 yes

6. CalPERS Side Fund Payout

In July 2014 the District will pay 22.504 percent of payroll towards the CalPERS retirement system. District staff requested from CalPERS to determine the lump sum payment amount for the District to reduce the pension liability. If the District remits \$786,357 by June 30, 2014 the percentage of payroll costs for the CalPERS pension will be reduced from 20.504 percent to 16.035 percent of payroll.

ACTION TAKEN: MOTION:

DIRECTOR TEAGUE made a motion to approve the payment to CalPERS side fund in the amount of \$786,357 and authorize the Treasurer to sign the check to remit to CalPERS before June 30, 2014. DIRECTOR DURAN seconded the motion. Motion carried by the following vote: 5 yes
