3. Project Status by MWH Global on the VSD Treatment Plant Master Plan

The first progress meeting regarding the VSD Treatment Plant Master Plan was presented by Mr. Paul Wallace from MWH Global. He presented to the Board a power point that covered existing influent quality, existing conditions – peaking factors, existing process capacity, build-out flows and load and preliminary site plan.

4. Update – East Valley Reclamation Authority JPA

MR. GLOWITZ and DIRECTOR WISEMAN briefed the Board on the December 9, 2014 meeting of the East Valley Reclamation Authority. A request for approval of the preparation of the EVRA fiscal year 2013-14 audited financial statements was made. MR. GLOWITZ reported on the update of the Reclaimed Water Project and the request of Indio Water Authority to pass a resolution in support of the Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Water Bond). The next meeting is scheduled for March 3, 2015.

5. Invitation to Bid – Solar Photovoltaic Project

MR. GLOWITZ informed the Board that the application requirements with the Imperial Irrigation District for the solar rebate grant are being finalized, as is the Invitation to Bid for the construction for the Photovoltaic Solar system at the Water Reclamation Facility. It is requested that the staff move forward with the Invitation to Bid which is anticipated to be issued in January 2015.

6. Benefits Update

The District is moving forward with a change in providers for life insurance, accidental death and dismemberment (AD&D) and long term disability (LTD) care for employees. This change from Assurant Employee Benefits to Standard Insurance Company will provide increased benefits and increased coverage at a lower cost, with a 3 year rate guarantee.

7. Manager's Notes

MR. GLOWITZ informed the Board that the City of Coachella has declined to join the Salt and Nutrient Management Plan (SNMP). He also distributed a letter from the Coachella Valley Mosquito and Vector Control District and an article on Rebuilding the U.S. Water System. The CASA Conference will be held in January in Palm Springs. MR. GLOWITZ has requested to call in to the next board meeting on January 13, 2015.
