5. Award the Vegetation Maintenance & Removal Project Contract to Aquatic Environments, Inc. and Authorize the General Manager to Execute a Maintenance Contract

Pursuant to an agreement with the Coachella Valley Mosquito and Vector Control District (CVMVCD), Valley Sanitary District is required to assist with the abatement of the mosquito population in and around the bulrush treatment area. As part of this effort, CVMVCD has requested that the District remove or trim as much of the vegetation around each pond as possible before each summer while still maintaining their effectiveness in treating the pond water. It is recommended that the Board of Directors award the Vegetation Maintenance & Removal Project contract to Aquatic Environments, Inc., and authorize the General Manager to execute a maintenance contract not to exceed \$147,730 to remove and dispose of the bulrush and other vegetation around the three ponds in the bulrush treatment area.

DIRECTOR TEAGUE made a motion to award the Vegetation Maintenance & Removal Project to Aquatic Environments, Inc. and authorize the General Manager to execute a maintenance contract for a not to exceed amount of \$147,730 to remove and dispose of the bulrush and other vegetation around the three ponds in the bulrush treatment area.
