4. CalPERS Unfunded Accrued Liability (UAL) Lump Sum Payment

If the District remits \$71,139 by August 1, 2015, the annual savings will be \$2,325.

5. Front Wall and Entrance Improvement Project – Design and Construction Management Services

Staff is requesting a final cost estimate to be performed on the completed plans in order to better understand the total anticipated cost of this project. Urrutia solicited a proposal from Cumming, a consultant who specializes in preparing cost estimates. The consultant will invoice Urrutia and the cost will be passed on at no additional costs to VSD. The cost of Cumming's proposal is \$5,780. Staff also solicited a proposal from Urrutia to perform construction management services on an as needed basis. Staff will be managing the project internally and will utilize Urrutia only for items needing their expertise. The cost of Urrutia's proposal is \$4,200.
