Pursuant to Government Code Section 6062a, notice was given of the Public Hearing regarding the adoption of the Mitigated Negative Declaration (MND) for the proposed Requa Interceptor Project. A Notice of Availability / Notice of Intent to Adopt a Mitigated Negative Declaration was published in The Desert Sun, a newspaper of general circulation, on September 13, 2015 as required by Government Code and distributed through the State Clearinghouse to other agencies for their review and comment. The public review period started September 14, 2015 and ended October 13, 2015. The District received one comment letter from the State Water Resources Control Board indicating the environmental requirements of the State Revolving Fund application process. These comments were included within the updated Initial Study –Mitigated Negative Declaration. DIRECTOR TEAGUE declared the public hearing open for public comment at 1:14 p.m. There being no correspondence, public comments or additional comments from the Board, DIRECTOR TEAGUE declared the Public Hearing closed at 1:16 p.m.

The teams were evaluated based on project understanding, approach & methodology, identification of key issues, team qualifications, firm experience, and team presentation & interview. Staff entered into a scope and fee negotiation process with MWH Global. The MWH team presented a base scope plus the requested contingency tasks that include an additional 45 day project extension and additional work contingency. Staff has reviewed the tasks and has determined they meet the requirements of the RFP. Staff worked with MWH to refine the project fee that was more appropriate for the level of effort required, as determined by the District.
