Linda Sue Dervishi of One Stop Shoppe introduced Haki Dervishi of One Stop Shoppe and Russ Samuels. Russ Samuels gave public comment on a Notice of Violation and a Cease and Desist that One Stop Shoppe received. They were notified that they need to install a grease interceptor. He stated that One Stop Shoppe has requested the results of the samples taken showing them to be a grease generator. The owners of One Stop Shoppe have been in contact with the District but they would like further information as to why they need to install a grease interceptor. Mr. Samuels also inquired as to why the Equivalent Dwelling Units for One Stop Shoppe has been increased from three (3) to five (5). Haki Dervishi also gave public comment to the Board. He stated that his taco shop has been in business for more than twenty years and is curious as to why he is being singled out now. He provided the Board with a copy of the original Bill of Sale from 1988. DIRECTOR COLEMAN informed Mr. & Mrs. Darvishi and Mr. Samuels that because this is public comment and not an agendized item that unfortunately the Board could not give comment regarding their inquiries.

3. General Manager's Report

Mr. Glowitz informed the Board that the finishing touches are being put on the Final Budget for 2018/19 Fiscal Year. Development is moving along. Staff has been meeting with Harris and Associates on the Downtown Sewer Rehabilitation and will come back to the Board soon with their vision for the project. Mr. Glowitz reported that his meeting with the lobbyists in Washington D.C. went very well. The District will be hosting a Retirement Party for Mike Lopanec on May 10, 2018. Mike will be retiring from the District on May 18, 2018 after 32 years of service.
